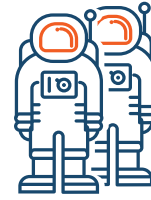

Cosigned Credit-Based Loan

Ascent's Cosigned Credit-Based Loan is available to undergraduate and graduate students with little to no credit history, utilizing a creditworthy cosigner with an income greater than \$24,000/year.

AFFORDABLE RATES

- Competitive fixed rates available on 5, 7, 10 and 12-year repayment terms.
- Competitive variable rates available on 5, 7, 10, 12 and 15-year repayment terms.

COSIGNER RELEASE

Students can request to release their cosigner and continue with the loan in only their name after making the first 24 consecutive payments on-time.

FLEXIBLE TERMS

Flexible 5, 7, 10, 12 or 15-year* repayment terms. There is no penalty for early repayment.

LOAN LIMITS

Minimum: \$2,001

Maximum for academic year: \$200,000

Maximum: \$200,000 (aggregate)

NO FEES

No origination, disbursement or loan application fees.

PAUSE PAYMENTS

Ascent Student Loans include Active Duty Military Deferment, In-School Deferment, Residency / Internship Deferment and Temporary Hardship Forbearance.*

REPAYMENT OPTIONS

- **In-school interest-only repayment:** Pay interest only while enrolled at least half-time.
- **Deferred repayment:** Start payments up to 6 months after graduation.
- **\$25 minimum payment:** Pay a set monthly payment while enrolled at least half-time.
- **Graduated repayment option:** Initially pay less once repayment begins.*

ELIGIBILITY

We consider several factors including: creditworthiness, school, program, graduation date, major, cost of attendance and other factors. Ascent's Cosigned Credit-Based Loan is for college students who are at least half-time enrolled in a degree program at an eligible institution. Students who are not a U.S. citizen or U.S. permanent resident may apply with a creditworthy cosigner who is a U.S. citizen or U.S. permanent resident.

REWARDS

- **0.25% interest rate reduction** for payments made via automatic debit.
- **1% Cash Back Reward** after graduation.
